CLAUSES INCORPORATED BY FULL TEXT

52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS--COMMERCIAL ITEMS (JAN 2004)

(a) Definitions. As used in this provision:

"Emerging small business" means a small business concern whose size is no greater than 50 percent of the numerical size standard for the NAICS code designated.

"Forced or indentured child labor" means all work or service-

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

CLIMBING WALL SPECIFICATIONS

Indoor Climbing Wall Project for Youth Services, Bldg 297

The indoor climbing wall specifications are as follows:

The climbing wall will be installed in the corner of the Gym/multi-purpose activity room. This is a cement cinder block (8" x 16") structure with approximate ceiling height of 30 feet.

BC plywood face with T-nuts installed on an 8 " grid.

The wall will have an ASDI premium acrylic texture.

Modular climbing holds (approximately 1 per 3 sq. ft.)

The climbing wall will extend approximately 15 feet out along each of the two walls from one corner of the building.

Height of the wall shall be 24 feet.

The wall face will be spaced a distance of no more than 8-12 inches away from the building wall for the first 8 feet of each climbing surface to minimize interference with other activities.

Wall features above the height of 8 feet will protrude no more than 56 inches out from the building wall.

There will be at least one vertical climbing surface and three separate overhang structures of varied difficulty.

The wall will be designed for the instruction of lead climbing and will include a "belay ledge".

All construction will conform to and meet the Climbing Wall Industry Group (CWIG) standards for climbing wall installation.

Maximum force exerted by one climber at any point on the wall surface is considered to be 440 lbf. This is assuming to act on a 5' x 6' area resulting in an equivalent distributed load of 15 PSF.

Belay Bar Anchors will be used for the dynamic belay system and will be designed to support a load of 4400 lbs.

All dimension framing lumber shall be hem-fir #2 or better. All vertical wall studs supporting overhang features shall be 2" x 8".

Four auto belay devices shall be attached to the belay bars.

Attachable crash pads system shall be installed.
