

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in FAR Subpart 12.6, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; proposals are being requested and a written solicitation will not be issued. **W912CZ-04-T-0126** is being issued as a Request for Quote, which incorporates provisions and clauses for commercial items in effect through Federal Acquisition Circular 2001-24. This acquisition is reserved for small business concern. The associated **NAICS code** for this acquisition is **325188** small business standard size is 1,000 employees. Line Item 0001: Sodium Hypochlorite, Quantity 230 (15 gallon carboy) STATEMENT OF WORK (SOW) FOR SODIUM HYPOCHLORITE Contractor shall provide all transportation and other necessary materials to supply this requirement for Sodium Hypochlorite (12.5% solution strength) for disinfection of potable water and swimming pool water at Fort Wainwright, AK. The contractor shall also pick up empty carboy from the same Bldg location when full carboys are delivered. A) Approximate consumption will be approximately 1,500 gallons minimum and 1,875 gallons maximum. B) The contractor will be notified telephonically when nine (9) empty carboy are on hand at the Water Plant, Bldg 3565. Upon notification, the contractor shall within four (4) calendar days, deliver nine (9) full carboys and remove the empty carboys. C) All picks up and delivery under this contract will occur between 0800 and 1400 hours Monday thru Friday, and no delivery on Holidays. D) Names of persons authorized to place calls under this contract will be provided in the award. E) Upon initial delivery of the first time (9) carboys, the Water Plant will provide nine (9) empty carboys in exchange for full nine (9) carboys for each delivery thereafter. F) Since empty carboy will be exchanged for full carboy, it is requested that this contract be offered without a deposit charge for carboys. The following provisions in their latest editions apply to this solicitation: FAR 52.212-1, Instructions to Offerors, Commercial. FAR 52.212-2, Evaluation, Commercial Items (a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. The following factor will be used to evaluate offers: Price, delivery and technical capabilities. Delivery and Technical is equal to price. A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offers specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.
